

TARGET FIELD RULES of AAFT (Field Target Association Argentina)

RIFLE:

They are only permitted those who drive their shells by compressed air, PCP, spring or CO2 gas.

The gauges are allowed up to 6.35 mm (.25 ")

Chaperones are permitted to the extent that repetition is performed in the mode load "Single shot".

CATEGORY:

1) PCP WFTF: Carbines with air or gas CO2 including pre-compressed using to compress the air or gas in a pre-compression chamber (PCP) with a maximum power

up to 16.27 joules / 12 fp.

2) Spring WFTF: Carbines with direct drive system of spring, piston and spring. May be

fixed barrel or break. The maximum allowed for this category will be 16.27 joules / 12 fp.

3) Argentina PCP: Rifles with air or gas CO2 pre-compressed including those used to compress air or gas in a pre-compression chamber (PCP and CO2 pumping).

The maximum allowed for this category is 40 joules / 29.50 ft / lbs.

4) Spring Argentina: Carbines with direct drive system of spring, piston and spring. Can

be fixed barrel or break. The maximum allowed for this category is 40 joules / 29.50 ft / lbs.

5) CO2 Argentina: Carbines with CO2 system, includes using to compress only CO2 gas in a pre-compression chamber. Not permitted in this category CO2 those arms to which they incorporate greater pressure than usual for this gas by pumping or other inflation system. The latter category will join the PCP Argentina. The maximum allowed for this category is 40 joules / 29.50 ft / lbs.

To ensure the adequacy of weapons to such limitation, the procedure before the start of the

competition with chrony measurement using the same pellets that are declared (3 shots) and the gas pressure and power regulation to use in competition, applicable. After verification, both the gun and the bullets (in a can labeled) will be in stored in the racks that will be available for this purpose, unable from that point be manipulated until the moment of its use in competition turn, after which it refunded to the dealer along with ammunition. A tolerance of 5% in the measurement of potency.

Regardless of these 5 categories, can be incorporated further in the tournament establishing necessary, provided that do not alter the rules of the five above, to reward, for example, JUNIORS, OR WOMEN VETERANS (over 55) if the number of shooters / as present at each event warrants.

ELEMENTS OF AIM:

Allowed any form of optical sight. However, not allowing the use of

added whole or any device designed specifically to estimate the distance to which (laser range finder, optical or any other system). May be used or open sights closed.

Scopes may be used in any type, including those containing adjustment parallax.

They are not allowed the laser sights.

WHITE:

Be used folding target (knock-down), specific to the modality.

The distance from which you can shoot at targets, may not exceed 8 meters or than 50 meters from the position of the shooter.

All targets must be clearly and consecutively numbered in both its location as in lines of fire.

Have an impact zone, whose diameter may be:

Diameter of 15 mm - between 8 and 25 meters

Diameter of 20 mm - between 8 and 30 meters

Diameter of 30 mm - between 8 and 40 meters

Diameter of 40 mm - between 8 and 50 meters

When using a firing position "forced" (foot or knee) can not be done on target exceed 40 meters nor less than 25 mm KZ.

The number of targets with forced firing position can not exceed 20% of total target; possibly in the same way: 10% to 10% firmly and knees.

In Argentina categories should be used as a measure of reduced impact area: 25 mm. up to 40 meters long.

MISSILES:

The shells can only be of lead or lead alloy in all its variants and forms.

Pellets are expressly prohibited special or head of any design, whether or not lead, which are likely to bounce or cause excessive damage to the targets.

COSTUMES:

The / participants may use any type of clothing provided it does not help fix the weapon at the time of shooting.

Any type of hunting clothing is allowed, provided that it shows support for the weapon,

can fill / padding with cloth or felt with a thickness up to 30mm, but in no case must have or take a form that can support or containment of the butt of the rifle.

Wearing shooting is allowed.

The gloves shot is not allowed, while the use of a soft glove itself is allowed.

It allows the use of pads. They should have a flat surface. May be of removable type or be sewn to the pants but in no event to exceed 30mm total thickness.

After starting the test, the shooter may not change at all the type or amount of garments.

SHOOTING POSITION:

Basically are sitting, knee, standing and lying. Allowed to compete in any position

long as the gun is resting on the body of the shooter, the shooter can not, support in any artificial or natural element as a tree, shrub, chairs, stools, default terrain, etc., the trigger finger can never exceed the marks of the firing lines and mouth

barrel to always surpass during the firing sequence.

Not allowed bipod, tripod or any support system for the weapon. To the positions of lying shot, you can use a blanket or carpet.

It may establish a firing position determined in a particular street or across the competition to give it more difficult to develop the same or for safety reasons, but respecting the percentages of targets forced firing position above

above.
The straps of the rifle may be used only for transporting the same, can never serve to assist or support during the firing sequence.

DEFINITION OF SHOOTING POSITIONS

a) Position "sitting"

I. In the sitting position only three parts of the body may touch the floor, buttocks and both feet.

II. The maximum height which can have any shape seat is 15 cms., Measured with the

shooter sitting on it. In case of a bag, measure sandwiched between 2 tables.

III. The 15 cms. are measured from the floor to the highest point of the seat.

IV. The seat can be used as such but not as other support for the shot.

b) Position of "lying"

I. The weapon and arms from the elbow to the hands must be free of any support, whether natural or artificial.

c) Position "knee"

I. There should be only 3 points of support on the ground (2 feet and 1 knee). The left foot

back should be perpendicular to the ground. An authoritative support (bag or bank) can be used

to support the back foot or knee, the foot must be always in contact with the ground. The

hand supporting the weapon must be free of support from the wrist including it.

d) Position "stopped"

Consider any shot fired standing without help or support from outside the body of shooter.

For certain physical situations:

- Competitors can not adopt awkward positions due to certain physical situations, should inform the manager of the C competition in advance, and in revising a valid medical certificate.

- If the Competition Manager determines that no unfair advantage or disadvantage inform judges about their decision path.

ORGANIZATION OF THE LANES:

The targets are arranged in lanes, targets are not located at different distances may be two or more targets at the same distance in the same lane. Each lane will be

duly numbered.

All targets should always be resolved in numerical order established. In case of that a target is brought down outside the predetermined sequence, the target will forfeit the omitted

being recorded as zero points. If the target is in another lane shot, be computed as a fault, like the previous case. However, if the lane that has struck the target, has not yet been performed, the shooter may shoot at that target when it comes to their turn,

habiéndola previously reset.

If the goal position were allowed, the competitor could use a cushion or a seat not exceed the maximum height of 15 cm. from the base thereof to the top, this seat can not take back. The competitor may only use this seat wagered on him in either position regulation or allowed, but not for other purposes. So Moreover, the use of tapes for securing arms and legs is not allowed.

TIMES:

To resolve every lane, competitors will have a period equal to the number of targets in the lane 1 minute for preparation. The time is counted from the moment the shooter takes the shot position on the lane. Within this specified time shall be measured

DEVELOPMENT:

Competition count of at least 30 silhouettes.

It may provide the silhouettes on every lane distributed differently, depending on the amount of

silhouettes are available, but it is established that outlines the minimum is 2 and up to 5

silhouettes of lane.

Lane may have shapes that have a mandatory triggering position, ie standing or knee. The remaining targets will be shot in free position.

The use of adjustable rifle butts is allowed, the "hamster" are permitted, provided when does not have bindings that can be placed in the knee. The height is free, and the

design and inclination. Not to add or remove items from the butt of the rifle during the competition, except in appropriate cases and earlier (read physical situations)

It allows you to adjust the rifle butt during the competition.

Test shots allowed (not directed, but into the ground) with the permission of the judge

line or participants competing in the same squad and unloading of weapons.

Temporary abandonment is allowed to make repairs to parts of the arms to prevent or invalidate operation safety thereof. Not covered or maintenance or interventions to optics (zero reset or re-configuration).

The competitor may not leave the firing line with a loaded gun.

Note: it is absolutely forbidden to competitors, even with the permission of Competition manager or a linesman, replacement parts and access

to the area after adjustment towards the repair done. The scorecard will take over the

Competition Manager or the linesman, will set a maximum time for re-entry, the time spent on the route and the time allowed are transcribed in the card route.

SCORES:

It may make a shot at each target. Each blank shot, there will be one (1) point positive. Each blank shot NOT be counted as a zero.

ARBITRATION:

There will be a ref who will lead the competition.

There may be one or more arbitrators lane will oversee the shots and decide any dispute that may arise.

Any unresolved dispute will be raised when the referee.

Referee

In any matter that may arise and is not covered by these rules the referee will the last word.

SAFETY STANDARDS:

THESE RULES WILL BE STRICTLY SECURITY IMPOSED. ANYONE

THE VIOLATION WILL BE FORCED OUT OF RANGE AND PARTICIPATION

COMPETITION.

1 All rifles must remain unloaded in the range up to the line shot.

2 The rifles should always point away from people as those involved

witness the event. ONLY PERMITTED ON THE WEAPONS IN Face LINE

SHOT IN COMPETITION, AND ALWAYS IN THE DIRECTION OF THE TARGET.

3 In the line of fire, please observe the safety procedures-sense

common including:

- a) When a rifle is loaded into the firing line, the insurance will not be released until it is pointing toward the target and the shooter is ready to perform shot.
- b) At all times the shooter's finger should remain off the trigger until the shooter ready to take the shot.
- c) When loading the rifle the shooter must hold load lever or barrel while pellet is inserted to prevent accidental discharge of rifle and prevent injury to shooter or other shooters.
- d) Maintain adequate space between handles is a responsible and courteous to other shooters.
- e) When the umpire or ref, declared "ceasefire" the shooters opened the bedroom the rifle, the port of loading or disengage the bolt or charging handle to give understand that the "ceasefire" is safe.
- f) The arbitrator generally has the last word on safety issues.

4 Do not allow the presence of children in the line of fire. Junior shooters must be authorized by the ref, having previously been instructed in the rules of safety of this chapter.

5 will not be allowed alcohol or drugs at the shooting range before and during duration of the run. If a shooter shows obvious signs if any previously consumed will prevent your registration and will be expelled from it.
